# 2026 Food, Beverage & Lodging License Fees

License categories are determined by the type of food, amount of food handling, risk level of the food, and the size of the operations. The types of facilities listed are examples. They are not all-inclusive. The size or specific operation of a food facility may change the level from the one listed. An establishment may have multiple facilities. Facility categories will be determined by a plan reviewer. Fees listed are for licenses only; additional plan fees may apply. Unless stated otherwise, licenses are valid 2/1/2026 – 1/31/2027.

Establishment – the address at which licensable activities take place

Facility – Licensed activity within an establishment

Primary – Largest or highest risk level facility at an address.

Additional – One or more facilities at the same address.

## **Vending Machines** (Exempt – candy only or canned pop only machines – see vending application for more info)

• Non-exempt vending machines (coffee in a cup, snacks, combined candy/snack)	<b>Per Machine</b>	\$20

## **Low Limited Facility**

• Packaged snacks, not primary business	<b>Primary</b>	\$100
• Chips, pretzels	<b>Additional</b>	\$50
• Half-day childcare w/ snacks and milk only		
• Portable bar		
• No prep or ware-washing		

## **Low Facility**

<b>Packaged</b>	<b>Primary</b>	\$215
• Convenience store, pharmacy, warehouse	<b>Additional</b>	\$108

## **Open Food**

• Bakery, sales only
• Bulk food, not hazardous
• Coffee, fountain beverages only
• Farmers market stand, no samples
• Limited food
• Produce dept.: fruit w/ no prep
• Snack stand – hot dogs only
• Rental kitchen

## **Medium Limited Facility**

<b>Packaged</b>	<b>Primary</b>	\$405
• Small grocery store	<b>Additional</b>	\$202

## **Open Food**

• Bakery/bake off only: no prep, no decorating, all non-potentially hazardous
• Cafeteria, no prep
• Catered food, no prep
• Continental breakfast with waffle batter
• Test kitchen
• Other less than complete commercial kitchen
• Re-heating packaged food for hot holding

- Large grocery store

**Primary** \$612

**Additional** \$305

**Open Food**

- Bakery/bake-off: limited or full decorating, all non-potentially hazardous
- Bar
- Catering food vehicle
- Small kitchen (10 or fewer meals)
- Meat market: no prep
- Pizza
- Produce dept.: cutting fruit/vegetables
- School w/ catered food, minimal prep on-site

**High Small Facility**

Full menu, <175 seats and/or <500 meals (or equivalent portions combined – salad, entrée, dessert)

**Open Food**

- Bakery: potentially hazardous fillings or decorations
- Banquet kitchen
- Cafeteria
- Caterer
- Combo deli/meat market
- Commissary kitchen
- Complex cuisine
- Deli
- Family restaurant
- Fast food
- Meat market: prep & handling (if cured/smoked meat or ROP, HACCP plan required)
- School with food made on site or catered to other school(s)
- Small institution

**High Large Facility**

Full menu, >175 seats and/or >500 meals (or equivalent portions combined – salad, entrée, dessert)

- Family restaurant
- Fast food

- Potentially hazardous, temperature controlled, includes delivery vehicles and carts
