PUBLIC HEALTH

Hennepin County Public Health works to improve the health of all county residents by addressing social and environmental factors that impact their health and offering programs and services that help them be healthy.

Our department is committed to advancing health and racial equity. We recognize racism as a public health crisis and are working to support and co-create solutions with impacted communities.

Our department is organized in five service areas. A list of our current programs, services and initiatives is provided below.

Clinical Services

Clinical services helps people in Hennepin County stay healthy by offering low-cost medical and mental health services.

Cope: Provides 24/7 mental health crisis services for children, and adults. Cope mobile crisis teams can provide onsite help and respond to anyone in the county needing urgent response. 612-596-1223.

Health Care for the Homeless: A federally qualified health center providing primary medical care, mental health, and substance use services at community-based facilities serving individuals experiencing homelessness.

Mental Health Center: A certified community behavioral health clinic that provides a comprehensive range of mental health and substance use services, including assessment and outpatient treatment.

Public Health Clinic: a multilingual, multicultural clinic providing screening and treatment for sexually transmitted diseases, HIV testing, PrEP, tuberculosis control services, refugee health screening, immigration exams and family planning services. Includes the **Red Door Clinic**, Minnesota's largest STD/HIV clinic.

Community Health & Strategic Initiatives

Community health & strategic initiatives leads short-term planning projects and ongoing strategic initiatives to support community health and improve our department.

Climate Action: Works to establish how public health will address the health aspects of climate change.

Community Engagement (CE): Builds staff capacity for CE best practices across the department.

Community Health Improvement Partnership (CHIP): Partners with stakeholders from multiple communities and sectors to address complex



health issues together with a focus on community wellbeing and housing stability.

Healthy Aging: Supports the development of an age-friendly community to help seniors in Hennepin County live safely, enjoy good health, and stay involved.

Health Promotion: Reduces chronic disease and improves health equity by promoting healthy policies, systems and environments that support healthy behaviors. Priority areas include physical activity, healthy eating, tobacco prevention, mental wellbeing and substance use prevention.

Health and Racial Equity (HRE): Develops and implements strategies to integrate HRE principles into policies, practices into all areas of departmental decision-making.

Quality Improvement (QI): Coordinates the departments QI efforts and advancement of the QI culture. The goal is to fully integrate QI into the way the department does business, across all levels and programs.

Strategic planning: Develops and supports implementation of the department's strategic plan, defining priorities and direction.

Trauma Informed (TI): Develops and implements TI goals and strategies. The goal is for our department to become a trauma informed organization.

Workforce Development: Builds, develops, and maintains an innovative and engaged workforce through staff competency assessments, training, and professional development opportunities.

Family Health

Family health programs support children, pregnant HCPH-detailed-overview-041822and

parents. We focus on prevention and early childhood systems coordination to improve outcomes for families, especially families of color and families experiencing risk factors that can impact children's development.

Birth Defect Information System (BDIS):

Public health nurse monitoring and follow up for children with congenital birth defects, including early hearing loss detection and intervention.

Caring Connections 4 Kids (CC4K):

Comprehensive public health nursing assessment of overall wellbeing and resource connection for children involved with Child Protection Services.

Child and Teen Checkups (C&TC):

Enables well-child checkups for children and teens under the age of 21 who are on Medical Assistance. Services include help scheduling appointments, arranging transportation, connecting to community resources, and more.

Family Home Visiting (FHV):

Promotes positive birth outcomes and healthy child development by strengthening or restoring critical attachment relationships between parents and children.

Follow Along Program (FAP):

Monitors growth and learning through a series of questionnaires provided to participating families. Families also receive age-appropriate activity ideas and resources to promote child development.

Lead Follow-up:

Health monitoring in children with elevated blood lead levels.

Strong Beginnings:

Specialized early childhood education within community childcare centers.

Women, Infants, and Children (WIC):

Helps pregnant women, new mothers, babies, and young children eat well and stay healthy through

nutrition education, and breastfeeding support. Includes benefits to purchase nutritious foods, including fresh fruit and vegetables.

Health Protection

Health protection prepares for, prevents, inspects, and mitigates the negative health effects of infectious diseases and leads the department's efforts around assessment and evaluation.

Assessment, Epidemiology, and Informatics:

Collects, organizes and disseminates data to support decision-making and performance management and responds to communicable diseases.

Emergency Medical Services: Supports emergency medical services planning and regulations, working to ensure common standards for medical response and transportation.

Emergency Preparedness: Plans and ensures that proper systems are in place to respond and protect the health and safety of county residents during public health emergencies.

Environmental Health: Licenses and inspects food, beverage, lodging facilities, septic systems, pools, camps, and body art businesses; addresses environmental threats and public health nuisances.

ImmuTracks: Provides immunization registry services (ImmuLink); and ensures babies are up-to-date on immunizations (Baby Tracks).

Ryan White Program: Coordinates services for people with HIV/AIDS; administers federal funds that enable people to receive care; and provides

support to the Minnesota HIV Services Planning Council.
