

# HIV outbreak in Hennepin and Ramsey Counties: case characteristics – June 23, 2022

As of June 23, 2022, there are 102 HIV outbreak cases in Hennepin and Ramsey Counties among people who inject drugs (PWID) and/or who have a history of unsheltered homelessness. June 2022 is the 43rd month of the HIV outbreak; the HIV outbreak was retroactively determined to have begun in December 2018. This document describes the sociodemographic and epidemiological characsterics of the HIV outbreak cases.

### HIV outbreak cases over time

All cases diagnosed since December 2018 are epidemiologically linked to other outbreak cases as an injection drug equipment-sharing partner, sex partner, or encampment contact. You can find a full list of case counts and cumulative case counts by month and year in Appendix A: case count and cumulative count by month table. Unfortunately, two individuals have passed away between Dec 2018 – June 2022. They are still included in the counts below.

#### Race/ethnicity

The American Indian population is experiencing the greatest systemic barriers to HIV-related health information and service access in this HIV outbreak, including access to HIV prevention and care. This is demonstrated through empirical evidence, including information gathered through Hennepin County Public Health's community engagement efforts. Inequitable access to the social determinants of health (like housing, income, education, and healthcare) has resulted in the American Indian population being overrepresented in the outbreak. Addressing this HIV outbreak will require a cross-sector approach that addresses structural racism and the social determinants of health.

#### Multi-racial American Indian population

During <u>SHAPE 2018</u>, Hennepin County Public Health engaged with American Indian community leaders. They recommended including all individuals who identify as American Indian within that demographic category, regardless of whether they identified as American Indian alone or in combination with other races. Three of the five individuals who indicate multiple races identify as American Indian. Rates were calculated using these modified race/ethnicity groupings.

#### **Risk factors**

Individuals can have more than one risk factor.

Risk Factor	Case count	Percentage of cases
Injection drug use (IDU) alone	48	47.1%
Men who have sex with men (MSM)/IDU	49	48.0%
Encampment connection	49	48.0%
History of sex work	15	14.7%
History of incarceration	12	11.7%

Men who have sex with men (MSM) is based on sex assigned at birth, not gender identity, in line with the Centers for Disease Control and Prevention (CDC) definition. Both cis men and trans women who have sex with men are classified as MSM. While the majority of cases are among people who inject drugs (PWID), cases are included if they have lived in an encampment in Minneapolis or St. Paul or are "named as a sex partner to a case meeting other outbreak-related criteria."

#### Drug(s) used

50% of cases (n=40) reported drug use at the time of their case interview. Some noted using more than one drug. This information was last updated on August 20, 2021.



## HIV outbreak response and service provider map

Many outbreak cases are encamped along the Midtown Greenway and the five highlighted neighborhoods of Minneapolis. Most HIV outbreak cases have received their *most recent* HIV medical care at Hennepin Healthcare. Allina Health Uptown Clinic and Native American Community Care also provide HIV medical care. Hennepin County Public Health emphasizes *most recent* HIV medical care as evidence suggests many of these patients are not retained in HIV medical care. Ryan White HIV/AIDS Program funded community-based organizations, like the African American AIDS Task Force, Indigenous Peoples Task Force, The Aliveness Project, and Youth and AIDS Projects, are serving HIV outbreak cases and are geographically located in the area where most identified unsheltered people with HIV reside. Health Care for the Homeless is providing services at encampments, the Adult Opportunity Center Catholic Charities Branch III, and Higher Ground. Red Door Clinic, part of Hennepin County Public Health, has conducted testing, disease investigation, and linkage services for HIV outbreak cases.
