# Instructions for an applicant with a felony who wants a name change with marriage license application

#### Step 1: Felon Name Change Notice (page 2)

- This form must be completed and sent to the appropriate authority if you are a felon and you want to change your name through the marriage license application process.
- Wait 30 days before moving to step 2.

Step 2: 30 days after you have submitted your felon name change notice, complete the forms on pages 3 and 4 and come in to a service center office to complete and pay for your marriage license.

- 1. Affidavit of Service (page 3)
  - You are documenting who and when your felon name change notice (page 2) was served, as required by statute.
  - This form must be completed by the applicant who is a felon.
  - This form must be notarized.
  - Form must be submitted when you come in to a service center to complete and pay for your marriage license application.

#### 2. Applicant Certification (page 4)

- You are documenting that 30 days have passed since serving the felon name change notice.
- This form must be completed by the applicant who is a felon.
- This form must be notarized.
- Form must be submitted when you come in to a service center to complete and pay for your marriage license application.
