- Culturally responsive maternal (post-partum) mental health specifically for black and indigenous birthing people needed.
- How are we getting mental health help and resources that is available to ethnic groups within HC and outside HC especially with the limited available of professionals? May Xiong has been in conversation with Commissioner Lunde on the possibility of forming a pathways program to address this situation
