#### So much new: funding, staff, programs

## Lots of new staff throughout the system!

 Goal is to better inform and create quick connections to the larger system and resources.

- American Rescue Plan Act funding was transformative to our system
- County was spending \$10 million on homeless response system, now closer to \$40 million

#### People with Lived Experience of Homelessness

It is **critical to our work** to truly integrate the voice of people with lived experience of homelessness into day-to-day systems work.

- Interview panels advise on recruitment
- Funding decisions advise on Request for Proposals (RFPs)
- Policy decisions review and advise on policies or procedures

#### Strategies making homelessness brief

- 1. Help people access communitybased resources as an alternative to shelter
- 2. Lower barriers to emergency shelter
- 3. Provide person-centered support focused on urgently moving people into housing
- 4. Maximize efficient and effective use of homeless-designated resources
- 5. Maximize use of mainstream housing resources

# What do we mean by system?



Help people access community-based resources as an alternative to shelter

#### Hennepin Shelter Hotline – System-wide shelter diversion

- Launched Monday, January 2nd, 2023
- People 18+ with and without dependents (i.e., singles, youth, and families) call 612-204-8200 if they are seeking shelter
- Catholic Charities is the contracted provider, partnering closely with the Adult Shelter Connect and Hennepin County Family Shelter Team

Lower barriers to emergency shelter

#### Recent system investment in emergency shelter

#### Improved shelter environments

- Women's Only Shelter
- Hope Street
- Renovations to shelter spaces

#### Reduced financial burden for shelter users

- Eliminated self-pay at Harbor Light Center
- Eliminated shelter costs in all family shelters

#### Increased shelter capacity

- Avivo Village
- AICDC Homeward Bound
- Family shelter overflow
- Additional shelter space during winter

#### Shelter can be accessed all day for:

• 75% single adult shelters

#### What is a By Name List?

A report with information on each household using the homeless response system

- Providers they're currently connected to
- Demographics
- Housing preferences
- Status of CES assessment and housing referrals

Relies on data entered in Homeless Management Information System (HMIS)

Supports accurate and equitable resource matching

- Increase of day shelters/drop ins for Winter 2023-2024


## **Best Practices in Action**



## Maximize use of mainstream housing resources

## Recent housing investments

Renovations of B&L and Single Room Occupancy housing

Creation of Single Room Occupancy buildings (new – beginning to lease up)

#### Affordable Housing Strategy

• HED finances the creation or preservation of around 1,000 units of rental housing each year that is affordable to households with incomes at or below 50% AMI, prioritizing units affordable to folks below 30% AMI

#### System priority and goal: Ending Chronic Homelessness by end of 2025

What is our process?

To use the By Name List and the Chronic Index to decrease inflow, increase outflow, and systematize efforts towards ending chronic homelessness

What are our results?

28% reduction in chronic homelessness since 2021

## System outputs


Drop-in Centers: over 3,000 unique individuals in last 12 months Hennepin Shelter Hotline: Almost 720 households served in first 3 months with almost 200 diverted Emergency shelters: 6,002 unique individuals stayed in shelter in 2022 Adult Shelter Connect: Made 36,693

reservations for shelter beds in 2022

Hennepin County Shelter Team: worked with 4,634 people in 1,042 households Copreinstred From 2,408 referrals in the past year, 79% of which were to POC Street outreach teams: worked with 1,402 unique individuals in 2022
