2026 Chair and Vice Chair Election Results

- Chief Werner was confirmed as the elected Chair of the CJCC by membership vote from the City of Minneapolis, suburban cities, and specialty law enforcement agencies for a two-year term beginning January 2026.

Intergovernmental Relations / Budget

Lead: Commissioner Lunde, CJCC Chair & Liz Young, Director Hennepin County Intergovernmental Relations

- Commissioner Lunde reported that the Hennepin County Board of Commissioners continues work reviewing use of the ballpark sales tax, including implications for county obligations and potential repurposing strategies.
- Budget outlook for 2026 was discussed. Emphasis on state/county coordination and anticipated legislative topics due to budget shortfalls were discussed.
- Reinforcement of the county's ongoing commitment to public safety partnerships, noting several operational and fiscal dependencies between agencies.
- Director of Intergovernmental Relations provided an overview of state-level activities, highlighting expected areas of legislative focus and opportunities for alignment with CJCC goals.

Chair Elect 2026 Mission Vision

Lead: Chief Werner, CJCC Vice-Chair

- Chair Elect Werner, shared direction for the 2026 CJCC and alignment with CJCC's mission and vision was reviewed, emphasizing:
 - A broader strategy for agency collaboration, particularly in areas of technology modernization, data sharing, system efficiencies, and community-facing service improvements.
 - Interest in exploring Al-assisted operational tools in nuanced, responsible, and ethical ways.
 - Updates on departmental progress since the previous meeting, including internal reviews, training improvements, and upgraded inspection cycles.
 - Positive feedback from the IACP Conference, noting increased national collaboration and visibility for Minneapolis and Hennepin County leadership.

Open Forum Information Sharing

Lead: Commissioner Lunde, CJCC Chair

- Coordination Between Courts, Defense, and Custody:
 - The committee discussed ongoing workload pressures and reaffirmed the need for improved coordination and clearer communication between the court processes, defense services, and detention operations.
- Operational Pressures & Facility Management Needs:
 - Updates were shared regarding staffing shortages, transport demands, and facility-capacity considerations. The committee emphasized the importance of timely information exchange and expressed appreciation for cross-agency support on urgent operational matters.

- Compliance, Readiness, and System-Wide Challenges:
 - The committee reviewed current inspection cycles, department readiness activities, and common system challenges such as staffing levels and aging infrastructure. Members highlighted the continuing value of close interagency collaboration.
- Data-Sharing Progress & Follow-Up Coordination:
 - Additional updates were provided regarding data-sharing improvements, ongoing follow-up items tied to earlier agenda topics, and the importance of raising emerging issues promptly to ensure coordinated solutions.
